## **Rules for Rates Application**

- 1. For import cargo: if there are several types of cargo in nature in one waybill, charging for storage is charged according to the highest rate.
  - For export cargo: if there are several types of cargo in nature in one air waybill storage of cargo is charged separately for each type of cargo. The minimum charge is calculated based on the total weight of cargo in the air waybill according to maximum rate.
- 2. In case of partial delivery of cargo under the same air waybill: storage is calculated for each shipment separately.
- 3. Storage is calculated on the basis of physical weight.
- 4. For cargo subject to deconsolidation: storage under a master air waybill is charged before payment for deconsolidation. Subsequent storage under a home air waybill is charged starting with the next day after deconsolidation.
- 5. The period of free storage of import goods is four days including the day of arrival.
- 6. The period of free storage of export goods is six days including the day of cargo acceptance to the warehouse.
- 7. Each commenced day is deemed full.
- 8. The service «Provision of a consignee slot for documents» is charged to the broker for each client included in the list of consignees whose documents are placed in the broker slot. Charge is made for each full month or a part thereof.
- 9. Services «Terminal handling of non-customs cargo without unpacking at the Cargo Terminal» and «Terminal processing of customs cargo without unpacking at the Cargo Terminal» are used under the following conditions:
- The cargo should arrive in a ULD. In case of beam loading, the rate does not apply.
- The ULD contains cargo of only one consignee.
- A preliminary request should receive from the consignee (at least an hour before the arrival of the flight) for the provision of the service, indicating the flight number, air waybill number and ULD storage position number. The request shall sent to Moscow Cargo by E-mail to info-feedback@moscow-cargo.com
- 10. Service «Provision of additional measures for cargo safekeeping (support)» is applied at the Client's request.
- 11. Service «Special marking of cargo» is provided at the Client's request.
- 12. Service «Deconsolidation/consolidation of cargo» is provided at the Client's request.
- 13. When returning cargo delivered for carriage, the consignor is charged equivalent to the amount of the cost of ground / terminal handling of cargo of the corresponding category.

- In case ground / terminal handling is included in the cost of carriage, the consignor is equivalent to the amount of the cost of ground / terminal handling of cargo of the corresponding category according to the tariffs on flights of other airlines (look at the tab "Rates on flights of other airlines" in the section "Rates" on the website www.moscow-cargo.com).
- 14. Service of express handling of import cargo is rendered subject to request submitted at least three hours before flight arrival at <a href="mailto:info-feedback@moscow-cargo.com">info-feedback@moscow-cargo.com</a> with reference to flight number and date, air waybill number, nature of cargo, number of items and weight.
- 15. In placement of vehicles in the customs control area each commenced day is deemed full.
- 16. Service «Additional processing in case of unconformity to the claimed character of cargo» is applied in case of identification of undeclared dangerous cargo delivery for carriage.
- 17. Service «Removal of cargo from the issuance area to the reception area» is applied when moving imported cargo of international airline released for internal consumption to the area of acceptance of export cargoes for dispatch with domestic airlines.
- 18. Service «Deconsolidation of cargo upon advance request» is provided subject to the conclusion of an agreement.
- 19. Printing documents received by E-mail is charged as production of document copies.
- 20. Service «Additional live animals care (AVI) upon consignor request» is provided for domestic animals only and includes feeding of animal with consignor fodder, equipment of cage with suspended water containers, provision/change of absorbent (napkins).
- 21. Dangerous cargoes carried without consignor declaration include "Biological materials, category B", magnetic materials, empty packs, lithium batteries, genetic materials, dry ice as refrigerant for general cargo.
- 22. Service «Fee for re-issuing documents for import/export cargo » is only provided at the Client's request and is used under the following conditions:
- changing the date or time of dispatch which requires downward adjustment of storage invoice;
- changing the payer for the services rendered.
- 23. In safe custody of cargo free storage period is not applied. If after the order of pass for pick-up the consignee has not picked up the cargo within 3 hours, the storage of cargo in the warehouse is charged as hailment.
- 24. Service «E-mail notice of cargo arrival» is provided on the basis of consignee written request.
- 25. Services «Acceptance for carriage of customs valuable cargo on special conditions», «Acceptance for carriage of non-customs valuable cargo on special conditions» are applied in delivery of cargo for carriage after a specified term but not later than 250 minutes before departure. The weight of cargo delivered for carriage must not exceed 150 kg.
- 26. Placement of cargo for the period of elimination of irregularities with the FAR requirements and the carriers' regulations in terms of packaging and labeling identified during delivery to the warehouse is applied if the cargo delivered to the terminal does not comply with the FAR requirements, namely:
- does not have shipping and / or transport markings;
- has damaged packaging or packaging that does not ensure the safety of cargo during transportation.

If the cargo is in not ready for carriage status, the consignor has the right to leave the delivery area of the terminal with the cargo without applying the specified fee. If the consignor's representatives carry out the elimination of irregularities in the technological area of the cargo terminal, the fee is applied in full.

<u>Exception</u>: not applicable for the import cargo moved from the delivery area to the receipt area at the request of consignee.

27. The service cargo release coordination is provided on the basis of a written application of the client, sent by e-mail service@moscow-cargo.com and includes:

- assistance and support in cargo collecting;
- sending scanned images of documents for cargo to the customer;
- preparation of documents for the cargo release, including cost calculations;
- ordering the transportation of cargo for loading by the appointed time;
- organization of cargo loading into the vehicle.
